1.	<b>Competition name:</b>	Father’s Day website competition
2.	<b>Promoter’s details:</b>	This Competition is conducted and organized by Blue Route Mall (“ <b>Mall</b> ”) and offered by Redefine Properties Limited (Registration Number: 1999/018591/06) (“ <b>Landlord</b> ”) and sponsored by Edge for Men and Gadget Time (“ <b>Sponsors</b> ”). In these T’s & C’s, we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you”.
<b>IMPORTANT INFORMATION</b>		
3.	<b>Eligibility: Who may enter the Competition?</b>	<p>To enter the Competition a participant (“<b>Participant</b>”) must be <b>18 (Eighteen)</b> years or older and in possession of a valid South African identity document or passport.</p> <p>No Minors are allowed to enter the Competition.</p> <p>Furthermore, a Participant needs to be in possession of an internet enabled device (“<b>Device</b>”) such as a cellular phone, tablet and/or laptop, such device must have access to the internet.</p> <p><b>Participants are advised that standard cellular or data rates as per the participants service provider will apply.</b></p>
4.	<b>Who cannot enter the Competition?</b>	The Competition may not be entered into by any director, member, partner, employee, agent, consultant, tenant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business

		partners or immediate family members, the Sponsor, employees of the Sponsor, agent and/ or consultant.
5.	<b>Competition Period:</b>	<p>The Competition will run from 1 June 2024 until 30 June 2024 (“<b>Competition Period</b>”).</p> <p>Any participation after the Competition Period will not be taken into consideration.</p>
6.	<b>How to enter?</b>	<p>To enter the Competition, a Participant will be required, for the duration of the Competition Period to:</p> <p>6.1 Visit the Mall’s website on <a href="https://blueroutemall.co.za/">https://blueroutemall.co.za/</a>. (“<b>Website Page</b>”);</p> <p>6.2 Then go to the WHATS ON Tab;</p> <p>6.3 Select the Competitions Option;</p> <p>6.4 Select Current Competitions;</p> <p>6.5 Follow the competition prompts; and</p> <p>6.6 Submit entry (“<b>Entry</b>”).</p> <p>Upon compliance with 6.1 – 6.6 above a Participant will automatically be deemed to have entered the Competition.</p> <p>There are no additional charges for participating in the Competition however, <b>standard data costs apply as per the Participant’s service provider and existing price plan for data usage with regards to uploading his/her Entry.</b></p>
7.	<b>Limitation on entries</b>	<p>A Participant may enter the competition only once during the Competition period.</p> <p>Any additional entries by the same Participant will be discarded before the winner selection takes place.</p>

9	<b>Winners announced on:</b>	The Winners will be announced no later than 9 July 2024 or at any such date the Landlord deems fit.
10.	<b>The prizes</b>	<p>The Winners shall each receive 1 of 3 <b>Edge for men</b> vouchers worth <b>R500.00 (Five Hundred Rands)</b> or 1 of 3 or <b>Gadget Time</b> vouchers each worth <b>R1000.00 (One Thousand Rands)</b> (“<b>Prize</b>”).</p> <p>None of the prizes may be transferred, changed, deferred, or exchanged for cash or for any other reason whatsoever.</p>

11.	<b>How will the Winner/s be informed?</b>	<p>The Landlord will contact the Winner/s using the Winner's email address and/or telephonically.</p> <p>If the Landlord is unable to contact or reach the Winner within 14 (Fourteen) days of having announced the Winner, the Entry by that person will be disqualified and the Landlord shall be entitled to perform a further electronic selection to determine another winner. That winner will also be contacted using email addresses and telephonically, as soon as reasonably practicable.</p>
