Promoter's details:	This Competition is conducted and organized by Blue Route Mall (" Mall ") and offered by Redefine Properties Limited (Registration Number: 1999/018591/06) (" Landlord ") and sponsored by ManiPedi and Carlton Hair (" Sponsors "). In these T's & C's, we refer to the above promoter(s) as "the Landlord" and the entrants as "the Participant(s)" or "you".
IMPORTANT INFORMATION		
3.	<u>Eligibility:</u> Who may enter the Competition?"	<p>To enter the Competition a participant ("Participant") must be 18 (Eighteen) years or older and in possession of a valid South African identity document or passport.</p> <p>No Minors are allowed to enter the Competition. Participants under the age of 18 will only be eligible under parent/guardian supervision.</p> <p>Furthermore, a Participant needs to be in possession of an internet enabled device ("Device") such as a cellular phone, tablet and/or laptop, such device must have access to the internet.</p> <p>Participants are advised that standard cellular or data rates as per the participants service provider will apply.</p>
4.	Who cannot enter the Competition?	The Competition may not be entered into by any director, member, partner, employee, agent, consultant, tenant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business

How will the Winner/s be informed?	<p>The Landlord will contact the Winner/s using email addresses and/or telephonically.</p> <p>If the Landlord is unable to contact or reach the Winner within 14 (Fourteen) days of having announced the Winner, the Entry by that person will be disqualified and the Landlord shall be entitled to perform a further electronic selection to determine another winner.
