2.	Promoter’s details:	This Competition is conducted and organized by Blue Route Mall (“ Mall ”) and offered by Redefine Properties Limited (Registration Number: 1999/018591/06) (“ Landlord ”) and sponsored by Crazy Store and Toys R Us (“ Sponsors ”). In these T’s & C’s, we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you”.
IMPORTANT INFORMATION		
3.	Eligibility: Who may enter the Competition?”	To enter the Competition a participant must be 18 (Eighteen) years or older and in possession of a valid South African identity document or passport with a valid temporary or permanent residence permit for South Africa (“ Participant ”). No Minors are allowed to enter the Competition. 4.	Who cannot enter the Competition?
