<b>IMPORTANT INFORMATION</b>		
<b>3.</b>	<b><u>Eligibility:</u> Who may enter the Competition?"</b>	To enter the Competition, a Participant must be 18 years or older, in possession of a valid South African identity document or passport.  Furthermore, a Participant needs to be in possession of an internet enabled device (Device) such as a cellular phone, tablet and/or laptop.
