1.	<b>Competition name:</b>	WIFI, Facebook and Website Survey Competition
2.	<b>Promoter’s details:</b>	This Competition is conducted and organized by Blue Route Mall (“ <b>Mall</b> ”) and offered by Redefine Properties Limited (Registration Number: 1999/018591/06) (“ <b>Landlord</b> ”) and sponsored by Blue Route Mall “ <b>Sponsor</b> ”). In these T’s & C’s, we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you”.
<b>IMPORTANT INFORMATION</b>		
3.	<b>Eligibility: Who may enter the Competition?”</b>	<p>To enter the Competition a participant (“<b>Participant</b>”) must be a <b>Cape Town resident, 18 (Eighteen)</b> years or older and in possession of a valid South African identity document or passport.</p> <p>No Minors are allowed to enter the Competition. Furthermore, a Participant needs to be in possession of an internet enabled device (“<b>Device</b>”) such as a cellular phone, tablet and/or laptop, such device must have access to the internet.</p> <p><b>Participants are advised that standard cellular or data rates as per the participants service provider will apply.</b></p>
4.	<b>Who cannot enter the Competition?</b>	The Competition may not be entered into by any director, member, partner, employee, agent, consultant, tenant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business

Upon compliance with 6.1 – 6.4 above a Participant will automatically be deemed to have entered the Competition.
