3.	<u>Eligibility:</u> Who may enter the Competition?”	<p>To enter the Competition a participant (“Participant”) must be 18 (Eighteen) years or older and in possession of a valid South African identity document or passport.</p> <p>No Minors are allowed to enter the Competition.</p> <p>Furthermore, a Participant needs to be in possession of an internet enabled device (“Device”) such as a cellular phone, tablet and/or laptop, such device must have access to the internet.</p> <p>Participants are advised that standard cellular or data rates as per the participants service provider will apply.</p>
4.	Who cannot enter the Competition?
